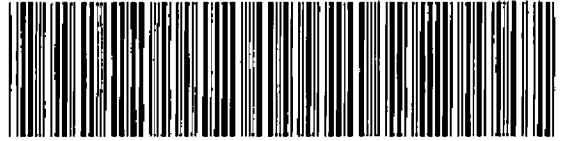

The undersigned does hereby execute these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

**ARTICLE I**  
**NAME**

**ARTICLE VI  
MANAGEMENT**

RESTRICTIONS ON MEMBERSHIP**




