TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of June 4, 2018 by (i) SILICON VALLEY BANK, as Administrative Agent (the "*Agent*") in favor of (ii) CLEARSLIDE, INC., a Delaware corporation (the "*Grantor*").

WHEREAS, the Grantor previously executed and delivered that certain Trademark Security Agreement dated as of February 23, 2018, (as amended, modified or supplemented prior to the date hereof, the "*Agreement*"; capitalized terms used but not defined herein shall have the meaning ascribed to them in the Agreement), granting the Agent a security interest in and lien on, among other things, the Trademarks, including, without limitation, the trademarks and trademark applications described on Schedule A attached hereto and made a part hereof;

WHEREAS, the Agreement was recorded in the United States Patent and Trademark Office ("*USPTO*") on February 27, 2018, at Reel 6279, Frame 0466;

WHEREAS, the Grantor has paid all outstanding amounts currently owing under the Credit Agreement and the other financing documents executed in connection therewith and the Agent has agreed to terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under the Trademarks; and

WHEREAS, the Grantor has requested that the Agent provide a document suitable for recording in the USPTO to evidence the release of its security interests in the Trademarks described in the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases, cancels, terminates and discharges any and all liens and security interests in Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, and re-assigns to the Grantor any and all right, title or interest it may have in such Trademarks. Agent hereby authorizes the Grantor, or the Grantor's authorized representatives, to record this Termination and Release with the USPTO and/or any other applicable governmental office. Agent agrees that it shall, and at Grantor's, or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to Grantor all further releases and other documents, and take all other actions reasonably necessary for the release of such security interest. **THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.**
