**TERMINATION AND RELEASE OF
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of First Lien Security Interest in Trademarks (“Release”) is made as of July 30, 2018, by **MACQUARIE CAPITAL FUNDING LLC**, a Delaware limited liability company (“Collateral Agent”) in favor of **STRATFORD SCHOOL, INC.**, California corporation with an address at 12930 Saratoga Ave., Suite A-2, Saratoga, California 95070 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a Trademark Security Agreement dated October 2, 2017 with the Collateral Agent, notice of which was recorded on October 2, 2017 at the United States Patent and Trademark Office at Reel 6168, Frame 0636.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of its right, title and interest in, to and under its Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates, cancels and discharges any and all of its Security Interest in the Trademark Collateral of the Grantor, including the goodwill of the business with which the Trademarks are associated, and re-assigns, re-transfers and re-conveys to Grantor any and all right, title and interest the Collateral Agent may have in, to, and under the Trademark Collateral. The Collateral Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record the this Release.

This Release shall be construed in accordance with and governed by the laws of the State of New York.
