TRADEMARK ASSIGNMENT

Assignor hereby assigns to Assignee the entire business associated with the Mark and the Registrations.

2. Assignor shall promptly, upon the request of Assignee, execute such other documents and/or instruments of assignment, transfer and conveyance as Assignee may reasonably request to permit Assignee to record the assignment made by this instrument or any other documents Assignee may reasonably deem necessary or advisable to effectuate the terms and intent of this Trademark Assignment.
