RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST, effective as of July 30, 2018, is made by Delaware Life Insurance Company, as Collateral Agent, pursuant to the Security Agreement defined below (“Secured Party”), having a place of business at 96 Worcester Street, Building I Wellesley Hills, MA 02481;

WHEREAS, Advanced Technology Group, Inc., a Pennsylvania corporation (“Grantor”), having a place of business at 5401 N. Central Expressway, Suite 300 Dallas, TX 75205, executed and delivered that certain Trademark Security Agreement dated as of March 17, 2015 (the “Security Agreement”), in favor of Secured Party;

WHEREAS, pursuant to the Security Agreement, Grantor granted and pledged to Secured Party a security interest in and to Grantor’s right, title and interest in, to, and under the Trademark Collateral (as defined in the Security Agreement), including without limitation those trademarks and trademark applications as set forth on the attached Exhibit A;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on Reel 5480 and Frame 0573 on March 18, 2015; and

WHEREAS, the Secured Obligations (as defined in the Guaranty and Security Agreement, dated December 22, 2014, among Secured Party, Grantor, Associations, Inc. and certain other grantor parties) have been satisfied and Secured Party no longer claims an interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, Secured Party hereby unconditionally and expressly releases, terminates, and extinguishes its Security Interest (as defined in the Security Agreement) in the Trademark Collateral, including without limitation the Trademark Collateral identified on Exhibit A.


