RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS, dated and effective as of May 31, 2018 (this "**Release**"), is made by **UBS AG, Stamford Branch**, as administrative agent (in such capacity, the "**Agent**") for certain secured parties pursuant to the Credit Agreement (as defined below), in favor of (i) **Vencore, Inc. (f/k/a The SI Organization, Inc.)**, a Delaware corporation, (ii) **Vencore Labs, Inc. (f/k/a TT Government Solutions, Inc.)**, a Delaware corporation, (iii) **PhaseOne Communications, Inc.**, a Delaware corporation, (iv) **Vencore Services and Solutions, Inc. (f/k/a QinetiQ North America, Inc.)**, a Delaware corporation, (v) **Westar Display Technologies, Inc.**, a Nevada corporation, and (vi) **SimAuthor, Inc.**, a Colorado corporation ((i) through (vi) collectively, the "**Grantors**").

WHEREAS, pursuant to (a) that certain First Lien Credit Agreement, dated as of May 23, 2014 and as amended as of June 17, 2016, by and among Vencore Holding Corp. (f/k/a The SI Organization Holding Corp.) ("**Holdings**"), Vencore, Inc. (f/k/a The SI Organization, Inc.) (the "**Borrower**"), the lenders from time to time party thereto and the Agent (as further amended, restated, supplemented or otherwise modified from time to time, including all exhibits and schedules thereto, the "**Credit Agreement**"), and (b) that certain First Lien Guarantee and Collateral Agreement, dated as of May 23, 2014, by and among the Agent, Holdings, the Borrower and the other grantors from time to time party thereto (as amended, restated, supplemented or otherwise modified from time to time, including all exhibits and schedules thereto, the "**Collateral Agreement**"), the Grantors granted to the Agent a security interest in and to certain collateral, including the trademarks and trademark applications identified on **Exhibit A** to this Release (the "**Trademark Collateral**");

WHEREAS, pursuant to the Credit Agreement and the Collateral Agreement, the Grantors executed and delivered a First Lien Grant of Security Interest in Trademark Rights, dated as of May 23, 2014, which was recorded in the United States Patent and Trademark Office on May 23, 2014 at Reel 5286, Frame 0016 (the "**Trademark Security Agreement**"); and

WHEREAS, each Grantor has fully satisfied all of its obligations under the Credit Agreement and the Collateral Agreement and all security interests in the Trademark Collateral are fully discharged and released, and the Trademark Security Agreement is canceled and terminated.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby agrees as follows:


1. **Termination and Release.** The Agent hereby (a) terminates and cancels the Trademark Security Agreement, and (b) releases, discharges, terminates and cancels all of its lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral, and any goodwill associated with the foregoing. The Agent hereby authorizes and requests the Director of the United States Patent and Trademark Office to record this Release against the Trademark Collateral.


2. **Governing Law.** This Release is governed exclusively under the laws of the State of New York.

3. **Successors and Assigns.** This Release shall be binding upon the Agent's successors, assigns, transferees and other legal representatives, and is made in favor of and for the benefit of the Grantors.
