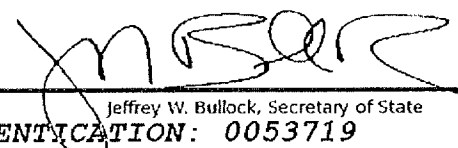

FIRST: That the names and states of incorporation of the constituent corporations are as follows:

SECOND: That the Corporation owns 100% of the outstanding shares of the common stock, without par value, of Oystar NA, which is the only class of stock of Oystar NA outstanding.
