## TRADEMARK ASSIGNMENT AGREEMENT

### RECITALS

**WHEREAS**, AJS Beverages, Inc. ("**Assignor**"), a California corporation, is the registered owner of the entire rights, title, and interest in and to a certain trademark, and the goodwill of the business associated with said mark;

**WHEREAS**, Scout Beverages, Inc. ("**Assignee**"), an Oregon corporation, desires to acquire the entire right, title, and interest in and to said trademark and the goodwill of the business associated with said mark; and

**NOW, THEREFORE**, the parties agree as follows.

### AGREEMENT

#### **SECTION 1    ASSIGNMENT**

For good and valuable consideration, the receipt, adequacy, and sufficiency of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee all of its rights, title, and interest in and to the trademark with Registration Number 5472402, together with the goodwill of the business associated with said mark. Assignor agrees to perform all reasonable and proper acts which Assignee may require in order to vest all of Assignor's rights, title, and interest in and to said mark in Assignee or its successors.

#### **SECTION 2    GENERAL**

- 2.1    Binding Effect.** This Agreement will be binding on the parties and their respective heirs, personal representatives, successors, and permitted assigns, and will inure to their benefit.
- 2.2    Further Assurances.** The parties will sign other documents and take other actions reasonably necessary to further effect and evidence this Agreement.
- 2.3    Governing Law.** This Agreement is governed by the laws of the State of Oregon, without giving effect to any conflict-of-law principle that would result in the laws of any other jurisdiction governing this Agreement.
- 2.4    Entire Agreement.** This Agreement contains the entire understanding of the parties regarding the subject matter of this Agreement and supersedes all prior and contemporaneous negotiations and agreements, whether written or oral, between the parties with respect to the subject matter of this Agreement.
