NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment Agreement (the “Agreement”), effective as of June 30, 2016, is entered into by 7 Plus Entertainment, LLC DBA TicketingBox (“Assignor”) and Tian Lu International, Inc. (“Assignee”).

WHEREAS, Assignor desired to convey all right, title, and interest in and to the Trademark to Assignee; and


WHEREAS, it is desired that the assignment of the Trademark listed in the attached Schedule A be made a matter of record in the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the mutual covenants contained in this Agreement, and for other good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor hereby sold, assigned,

transferred, and conveyed unto Assignee all of its right, title, and interest, whether statutory or common law, in and to the aforesaid Trademark, including any choses in action relating to said Trademark, claims for damages, profits, and costs, both in equity and law, for any infringement, infringements, dilution, or other violations of said Trademark rights accruing on or before the effective date of this Agreement, together with the goodwill of the business associated with and symbolized by the Trademark and including the registration thereof as set forth in the attached Schedule A, nunc pro tunc effective June 30, 2016, and further, hereby covenanted, agreed, and undertook to execute, whenever requested by Assignee, all applications, assignments, lawful oaths, and any other papers which Assignee may deem necessary or desirable for securing to Assignee or for maintaining for Assignee the Trademark hereby assigned, all without further compensation to Assignor.
