RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in all right, title and interest of Pledgor, and reassigns to Pledgor all right, title and interest that it may have, in and to the Intellectual Property Collateral, including without limitation the trademarks and patents identified on the attached **Schedule A**, without representation or warranty of any kind whatsoever.
