Release of Lien on Trademarks

**WHEREAS**, by a certain Grant of Security Interest in Trademark Rights, dated as of July 31, 2017 (the “**Agreement**”), among Intrawest Honua Kai Hospitality Management, LLC (“**Lien Grantor**”), JPMorgan Chase Bank, N.A., as Collateral Agent (“**Grantee**”), and the other grantors party thereto, which Agreement was recorded with the United States Patent and Trademark Office on August 8, 2017 on reel/frame 6125/0050, the Lien Grantor granted to Grantee a security interest in and lien on all right, title and interest in the trademarks and trademark applications owned by Lien Grantor and set forth on Schedule A hereto (including the goodwill associated with such trademarks and the right to receive all the Proceeds (as defined in the U.S. Security Agreement) therefrom) (collectively, the “**Trademarks**”);

**WHEREAS**, the sale or other disposition of the Trademarks is taking place as of the date hereof in accordance with the terms of and conditions of the Credit Agreement, dated as of July 31, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”; the terms defined in the Credit Agreement and not otherwise defined herein being used herein as therein defined), among Hawk Guarantor, LLC, Alterra Mountain Company (f/k/a Intrawest Resorts Holdings, Inc.), the several lenders from time to time party thereto and the Grantee (the “**Disposition**”);


**WHEREAS**, in connection with the Disposition, Grantee desires to release its security interest in and lien on the Trademarks;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantee does hereby release, terminate and cancel its security interest in and lien on the Trademarks and re-transfers, re-assigns and re-conveys to the Lien Grantor all right, title and interest of Grantee in and to the Trademarks.



The Grantee authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office and any applicable government officer record this Agreement.
