TRADEMARK ASSIGNMENT

January 26, 2018

THIS TRADEMARK ASSIGNMENT (this "Assignment") is delivered in connection with that certain Asset Purchase Agreement (the "Purchase Agreement"), dated as of January 26, 2018, by and among The Sierra Company LLC, a Minnesota limited liability company ("Buyer"), B&H International Inc., a Washington corporation f/k/a B. I. C. Corporation – Vancouver and d/b/a Burke Industrial Coatings ("Seller"), and the Shareholders party thereto. Capitalized terms used in this Assignment without definition have the respective meanings given to them in the Purchase Agreement.

A. Pursuant to the Purchase Agreement, Seller has agreed to sell, convey, transfer and assign to Buyer, and Buyer has agreed to purchase from Seller, all of Seller's right, title and interest in and to the Intellectual Property included in the Acquired Assets. Buyer and Seller now seek to consummate the sale, conveyance, transfer and assignment of certain of such Intellectual Property.

NOW, THEREFORE, intending to be legally bound and in consideration of the mutual provisions set forth in this Assignment and in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assigned Trademarks. Seller hereby sells, conveys, transfers and assigns to Buyer all of the Intellectual Property included in the Acquired Assets free and clear of any Encumbrance, other than Permitted Encumbrances, including the Intellectual Property listed in Exhibit A hereto, together with all goodwill associated therewith and all trademark registrations, applications and renewals in connection therewith, and all claims for damages by reason of past, present or future infringement, dilution or misappropriation of the foregoing, with the right to sue for and collect the same.

2. Subject to Purchase Agreement. This Assignment is executed and delivered pursuant to the Purchase Agreement, and is subject to every agreement, representation, warranty, indemnification, covenant and provision contained in the Purchase Agreement.

3. Counterparts. This Assignment may be executed in counterparts, and delivered by facsimile or other means of electronic communication, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


