**RELEASE OF SECURITY INTEREST**

This Release of Security Interest (“Release”) is made as of July 31, 2018 by COMERICA BANK, a Texas Banking Association (“Bank”), in favor of CENTER FOR ORTHOPEDIC RESEARCH AND EDUCATION, INC., THE CENTER FOR ORTHOPEDIC AND RESEARCH EXCELLENCE, INC., EXCELLENCE MANAGEMENT MICHIGAN, LLC, EXCELLENCE MANAGEMENT ARIZONA, LLC, CORE SPECIALTY SURGICAL HOLDINGS, LLC, THE MOTION STORE, LLC, VIRT2 HEALTH ANALYTICS, LLC, PHYSICIANS REAL ESTATE SOLUTIONS, LLC, and THE PORETTA CENTER FOR ORTHOPAEDIC SURGERY, P.C (“Debtors”).
