## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of July 31, 2018 ("Effective Date") by and between Leadership Platform Acquisition Corporation, a Delaware corporation (the "Secured Party"), as successor in interest to National Education Council Corporation, a Delaware corporation and Leadership Platform Acquisition Corporation ("Grantor"), as successor in interest to National Youth Education Council, LLC.

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between National Education Council Corporation and National Youth Education Council, LLC, a Florida limited liability company, dated August 30, 2012 (the "Trademark Security Agreement"), National Youth Education Council, LLC granted to National Education Council Corporation a continuing security interest in and to all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on August 30, 2012, at Reel 4853, Frame 581;

**WHEREAS**, pursuant to that certain Agreement and Plan of Merger, dated August 31, 2012, by and between National Education Council Corporation and Leadership Platform Acquisition Corporation, National Education Council Corporation was merged into the Secured Party and the Secured Party became successor in interest to all of National Education Council Corporation's rights and obligations under that certain Trademark Security Agreement;

**WHEREAS**, National Youth Education Council, LLC, a former subsidiary of Grantor, was administratively dissolved on September 6, 2014 in the state of Florida, after which Grantor became its successor in interest, including to its rights and obligations under the Trademark Security Agreement; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Secured Party and Secured Party has agreed to release the Trademark Security Agreement and the security interests and liens on the Trademark Collateral granted to Grantor pursuant thereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby (i) terminates and cancels the Trademark Security Agreement; (ii) terminates, discharges, cancels and releases any and all security interests, liens and mortgages it has in or against the Trademark Collateral; and (iii) reassigns, retransfers and reconveys to the Grantor any and all right, title or interest the Secured Party may have in the Trademark Collateral. The Secured Party hereby authorizes and requests that the Commissioner for Trademarks of the PTO record this Release.

Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; and (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to

register any trademark, or any trade name or assumed name, other than those Trademarks set forth on Schedule A (attached hereto), in any jurisdiction throughout the world.

Secured Party shall take all further actions and provide to Grantor, its successors, assigns or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
