We refer to the above US trade mark application (**Trade Mark**).


Pursuant to a business sale agreement as executed between VGW Holdings Limited (**VGW Holdings**) and VGW GP Limited (**VGW GP**), the Trade Mark was assigned to VGW GP. **Enclosed** is a copy of the executed confirmatory deed of assignment (**Deed**) confirming the assignment of the Trade Mark.

It is to our understanding that, under US trade mark law, it is a requirement that goodwill be assigned with the Trade Mark. The Deed, in its current form, does not specifically mention goodwill.


In order to record the assignment of the Trade Mark in the US, both parties to the Deed confirm that the Assigned Rights as reflected in the Deed refer to all the Intellectual Property Rights owned by VGW Holdings in the Trade Mark including any and all goodwill and reputation associated with the Trade Mark.

#### **Parties**

**VGW Holdings Limited** (ACN 147 193 511) of Level 8, 191 St Georges Terrace, Perth 6000, Western Australia (**Assignor**)

-and-

**VGW GP Limited** (CRN 78260) of Valletta Buildings, 4<sup>th</sup> Floor, Suite 20, South Street, Valletta, Malta (**Assignee**)

#### **Recitals**

- A. The Assignor is the owner of the Trade Marks.
- B. On or around 1 May 2018, the Assignor and the Assignee entered into a business sale agreement (**BSA**) which included an assignment of the Trade Marks from the Assignor to the Assignee.
- C. The purpose of this Deed is to confirm the assignment of the Trade Marks pursuant to the BSA for the purposes of recording the assignment of the Trade Marks.

#### **Agreed Terms**

##### **1. Definitions and Interpretation**

- 1.1. The definitions and rules of interpretation in this clause apply in this Deed:

**Assigned Rights** means all the Intellectual Property Rights owned by the Assignor in the Trade Marks.

**Deed** means this confirmatory deed of assignment.

**Effective Date** means 1 May 2018.

**Intellectual Property Rights** means such rights as may subsist in any trade marks, copyright, designs, patents, know-how, and any application or right to apply for registration of any of those rights in any territory.

**Trade Marks** means the trade marks, registered or otherwise, set out in the Schedule of this Deed.

##### **2. Assignment**

- 2.1. With effect from the Effective Date, pursuant to the BSA, and for valuable consideration, the Assignor assigns absolutely to the Assignee all its right, title and interest in and to the Assigned Rights in the world, including the right to bring, make, oppose, defend, and appeal proceedings, claims or actions, and obtain relief (and to retain any damages recovered) in respect of any infringement or any other cause of action arising from ownership of any of the Assigned Rights, whether occurring before, on, or after the date of this Deed.


- 2.2. The Assignor irrevocably appoints the Assignee as its exclusive attorney, in its name and on its behalf, to execute and enter into any and all deeds, documents, instruments, and correspondence, for the sole purpose of effecting and registering the above assignment of the Trade Marks with the trade marks office in the applicable jurisdiction.
- 2.3. The Assignor agrees that anything done by the Assignee in connection with the Trade Marks under this power of attorney will be as valid and effective as if the same had been done by the Assignor.

**3. Governing Law and Jurisdiction**

- 3.1. This Deed and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) is governed by and construed in accordance with the laws of the Commonwealth of Australia.
- 3.2. The parties irrevocably agree that the courts of the Commonwealth of Australia have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).




