Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of each constituent corporation is Lexpertz, Inc., a Delaware corporation, and Aderant North America, Inc., a Florida corporation.

SECOND: The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8, Section 252.

FIFTH: The merger is to become effective on July 10, 2018.

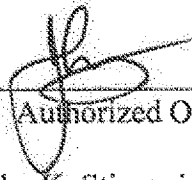
