RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest ("Release"), is made by Webster Bank, National Association ("Agent"), in favor of Everstream Solutions LLC, an Ohio limited liability company, and Everstream GLC Holding Company LLC, a Delaware limited liability company ("Grantors").

WHEREAS, pursuant to a Trademark Security Agreement dated June 1, 2016, by and among Grantors, Agent, and others party thereto (the "2016 Trademark Security Agreement") originally recorded in the Trademark Assignment database of the United States Patent and Trademark Office ("USPTO") on June 1, 2016, at Reel/Frame 005804/0340, Grantors granted to Agent a security interest in all of Grantor's right, title and interest in and to certain Trademark Collateral identified in Schedule I attached to the 2016 Trademark Security Agreement; and

WHEREAS, Agent has agreed to release and discharge Grantor from the terms and conditions set forth in the 2016 Trademark Security Agreement only with respect to the EMPOWERING CONNECTIONS mark having a U.S. Registration No. 4654380 for the purpose of a Trademark Purchase Agreement being concurrently entered into by and between Everstream GLC Holding Company LLC and Johnson City Energy Authority d/b/a/ BrightRidge ("Assignee"); and

WHEREAS, Agent has agreed to permit Assignee to record with the USPTO this Release for the EMPOWERING CONNECTIONS mark.

NOW, THEREFORE, for good and valuable consideration, Agent does hereby release and discharge the security interest, liens, and all other rights, if any, it may have in the EMPOWERING CONNECTIONS mark.
