
WHEREAS, the Company is granting to Lender a security interest in the Marks, together with the good will of the business symbolized by the Marks;

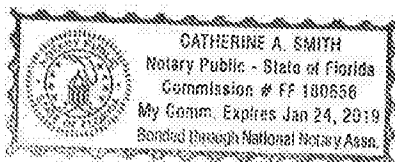
