RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Release of Intellectual Property Security Agreement (“IP Release”) is made as of June 22, 2018, by WESTERN ALLIANCE BANK, an Arizona corporation with an address at 55 Almaden Boulevard, Suite 100, San Jose, California 95113 (“Lender”) in favor of RELISH LABS LLC, a Delaware limited liability company with an address at 400 N. Michigan Ave., Suite 1400, Chicago, IL 60611 (d/b/a Home Chef and formerly organized in Illinois) (“Grantor”).

W I T N E S S E T H

WHEREAS, Grantor and Lender entered into a certain Loan and Security Agreement, dated May 26, 2016 (as amended from time to time, the “Loan Agreement”);

WHEREAS, Grantor and Lender entered into a certain Intellectual Property Security Agreement, dated October 11, 2016 (the “IP Security Agreement”), notice of which recorded on November 8, 2016 at the United States Patent and Trademark Office at Reel 5917, Frame 0275;

WHEREAS, capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement;

WHEREAS, to secure the Obligations under the Loan Agreement, Grantor granted to Lender a security interest in all right, title and interest of Grantor in any of the Intellectual Property Collateral, whether then existing or thereafter acquired or created, including the Copyrights described in Exhibit A, the Trademarks described in Exhibit B and the Patents described in Exhibit C and all additional rights and remedies thereto; and


WHEREAS, Lender has agreed to terminate and release its security interest in all such Intellectual Property Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, Lender hereby releases, terminates and discharges any and all of its security interest in any and all Intellectual Property Collateral, including the Copyrights described in Exhibit A, the Trademarks described in Exhibit B and the Patents described in Exhibit C, and assigns, transfers and conveys to Grantor any interest in or right to such intellectual property, including any goodwill associated with the use thereby.
