TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment"), is made and entered into as of June 1, 2018, by and between QUALITY BUILT, LLC, a Delaware limited liability company ("Assignor"), and HOMEID, LLC, a Delaware limited liability company ("Assignee").

WHEREAS, Assignor and Assignee entered into that certain Contribution and Exchange Agreement dated April 3, 2015 (the "Contribution Agreement"), and related transactions thereto, whereby Assignor contributed certain assets relating to Assignor's business, including certain intellectual rights in and to certain of Assignor's trademarks.

Assignor hereby contributes, assigns, transfers, conveys, and delivers to Assignee, free and clear of any mortgage, pledge, lien, charge, security interest, claim or other encumbrance, all of Assignor's rights, title, and interest in and to the Assigned Marks, together with all the goodwill of the business associated with the Assigned Marks, all other corresponding rights secured under the laws of the United States and all claims for damages by reason of past, present or future infringement or other unauthorized use of the Assigned Marks, including the right to collect all proceeds and damages therefrom.
2. Assignor hereby covenants and agrees that it has the full right to convey all right, title and interest assigned under this Agreement, and that Assignor has not executed, and will not execute, any agreement in conflict with this Assignment.
3. Assignor further covenants and agrees that should additional or further documentation of the assignment be required to protect, secure, vest and record good title to the Assigned Marks in Assignee, Assignor will, without further consideration, provide or execute such other information or documents as may be reasonably necessary upon Assignee's reasonable request.
4. Assignor hereby authorizes and requests the Commissioner for Trademarks of the United States Patent and Trademark Office to record Assignee as the assignee and owner of the Assigned Marks registered.
5. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
