THIS INTELLECTUAL PROPERTY SECURITY INTEREST ASSIGNMENT AGREEMENT (this “Agreement”) dated as of June 27, 2018 is by and among **MORGAN STANLEY SENIOR FUNDING INC.**, in its capacity as the Resigning Agent (as such term is defined in the Successor Agent Agreement (as defined below)) (in such capacity, the “Resigning Agent”), **CORTLAND CAPITAL MARKET SERVICES LLC**, in its capacity as the Successor Agent (as such term is defined in the Successor Agent Agreement) (in such capacity, the “Successor Agent”), and the parties other than the Resigning Agent and the Successor Agent identified on the signature pages hereto (the “Pledgors”);

WHEREAS, **JASPER PARENT LLC**, a Delaware limited liability company, **NINE WEST HOLDINGS INC.**, a Delaware corporation (the “Borrower”), the lenders from time to time party thereto and the Resigning Agent, entered into that certain Term Loan Credit Agreement, dated as of April 8, 2014 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, the Pledgors executed and delivered that certain Security Agreement, dated as of April 8, 2014, (as amended, restated, amended and restated, replaced, supplemented and/or modified, the “Security Agreement”) pursuant to which the Pledgors entered into the Intellectual Property Security Agreements listed on Schedule 1 (together, the “Intellectual Property Security Agreements”);

WHEREAS, pursuant to the Security Agreement and the Intellectual Property Security Agreements, the Pledgors pledged and granted to the Resigning Agent, for the benefit of the Secured Parties, a security interest in all of their right, title and interest in, to and under: (a) the United States Intellectual Property of the Pledgors listed on Schedule 2 attached hereto; (b) all goodwill associated with such Intellectual Property; and (c) all proceeds of any and all of the foregoing (collectively, the “Intellectual Property Collateral”);

WHEREAS, the Intellectual Property Security Agreements were recorded with the United States Patent and Trademark Office on the dates and at the Reel/Frame numbers set out on Schedule 1, or with the United States Copyright Office on the dates and at the Volume/Document numbers set out on Schedule 1, as applicable; and

WHEREAS, in connection with the resignation of the Resigning Agent and the appointment of the Successor Agent, pursuant to that certain Secured Term Loan Credit Agreement Agency Resignation and Appointment Agreement and First Amendment Agreement to Credit Agreement, dated as of April 6, 2018 (the “Successor Agent Agreement”), among the Borrower, the Successor Agent, the Resigning Agent, each other Loan Party signatory thereto and those Lenders under the Credit Agreement which are parties thereto, the Resigning Agent desires to evidence the assignment of the security interest granted to the Resigning Agent in the Intellectual Property Collateral to the Successor Agent for recordation with the United States Patent and Trademark Office and the United States Copyright Office.

5. Successors and Assigns. This Agreement is binding upon, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.





