TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made effective as of June 29 2018 by Lisa Shuster ("Assignor"), an individual with a principal address at 2717 Egret Way, Frederick MARYLAND 21701 to and for the benefit of Globoforce Ltd. ("Assignee"), an Irish corporation with a principal address at 19 Beckett Way Dublin, Ireland 12 pursuant to the terms of a Settlement Agreement between the Assignor and Assignee. The Assignor and Assignee are jointly referred to herein as the "Parties".

WHEREAS, Assignor owns all right, title and interest in and to the trademark WORKMOREHUMAN (the "Trademark") and Assignor wishes to assign to Assignee all of Assignor's right, title and interest in and to the Trademark and the related goodwill, including, without limitation, all trademark applications and registrations worldwide therefor, in particular the United States Trademark Application 87/555,966; and

WHEREAS, the Parties entered into a Settlement Agreement in which Assignor agreed to assign her trademark rights to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Assignor hereby acknowledges:


1. Assignor hereby assigns to Assignee, and Assignee accepts, all of Assignor's right, title and interest throughout the world in and to the Trademark and the goodwill of the business on which the mark is used, including, without limitation, all trademark applications and registrations worldwide.
2. Assignor further assigns to Assignee all causes of action for infringement of the Trademark together with any resulting recovery of damages, attorney's fees and costs from acts which may have occurred prior to the effective date of this Assignment.
3. Assignor covenants and agrees that, upon the request of Assignee, Assignor shall execute all papers, make all rightful oaths, testify on behalf of Assignee, furnish such documents, materials, information and/or assistance, and do all other lawful acts necessary to perfect the assignment of the Trademarks to Assignee and otherwise carry out the intent of this Assignment, provided that Assignee reimburses Assignor for its reasonable out-of-pocket expenses therefore.

4. This Assignment shall be binding upon Assignor, Assignor's successors and assigns, and upon all others acting by, through, with or under the Assignor's direction, and all those in privity therewith.
