TRADEMARK ASSIGNMENT

NOW, THEREFORE, Assignor does hereby assign, transfer and set over unto the Assignees in accordance with Schedule 1, its successors and assigns, the entire and exclusive right, title and interest in and to the Trademarks including all proceeds therefrom and the right to bring an action at law or in equity for any infringement, dilution or violation of any of the Trademarks occurring prior to the date hereof, and to collect all damages, settlements and proceeds relating to any of the Trademarks. Assignor further agrees to execute and have executed all documents, instruments and papers to perform all acts, as deemed reasonably necessary by the Assignees to perfect in the Assignees the foregoing rights, title and interests, including the execution of any related domestic or foreign application documents, provided that all costs and expenses associated with the recordation of assignment documents shall be born equally by the Assignees and Assignor.

This Trademark Assignment may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

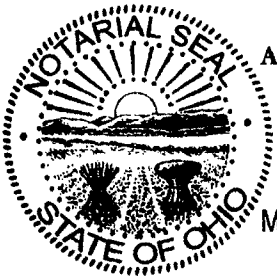
