## ASSIGNMENT OF TRADEMARK RIGHTS

Assignor will, without additional consideration, take such further actions and execute promptly such further documents as are necessary or desirable to transfer, vest, record and perfect good, valid and marketable title to the Trademark, including the Registration, in

Assignee. Assignor hereby authorizes Assignee to immediately request that the U.S. Patent and Trademark Office record Assignee as the owner of the Trademark, including the Registration.
