RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST is made on June 12, 2018, by FIFTH THIRD BANK, an Ohio banking corporation, as Administrative Agent ("Agent"), in favor of the Grantor (as defined below).

WHEREAS, MANUFACTURING RESOURCES INTERNATIONAL, INC., a Georgia corporation, ("Grantor"), pursuant to the Trademark Security Agreement dated June 30, 2015, (the "Security Agreement"), granted to Agent a lien on and security interest in the Trademarks as defined and described in the Security Agreement, which Security Agreement was recorded with the United States Trademark and Patent Office (the "PTO Recording") at Reel 5580, Frame 116, on July 16, 2015; and

WHEREAS, Agent has agreed to release its lien and security interest as a secured party under said Security Agreements with respect to such Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby agrees as follows:



The Agent hereby (i) releases, terminates and discharges to the Grantor its lien on and security interest in all such Trademarks, including, without limitation the Trademarks listed on Schedule I hereto, (ii) releases all other rights it may have under the Security Agreement with respect to any such Trademarks, including, without limitation the Trademarks listed on Schedule I hereto, and (iii) terminates the PTO Recordings.

2. The Agent hereby authorizes and acknowledges the termination of the Security Agreement (except for the provisions thereof which by their terms expressly survive termination). At the Grantor's sole cost and expense, the Agent hereby agrees to duly execute, acknowledge, and deliver any further customary documents and to do any such acts as may be reasonably necessary to affect the release of the security interest in such Trademarks contemplated hereby unless any of the foregoing actions would expose the Agent or any of its officers, directors, employees, agents, attorneys and other representatives to personal liability or would be contrary to applicable law.
