**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY RIGHTS**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS (this "Release"), dated as of August 9, 2018, is made by Antares Capital LP, as administrative agent (in such capacity, "Agent"), in favor of Washing Systems, LLC, an Ohio limited liability company ("Grantor"), as follows:

WITNESSETH:

WHEREAS, reference is made to the Loan and Security Agreement dated as of November 30, 2015 (as amended, restated, supplemented or otherwise modified to date, the "Loan Agreement"), by and among the Grantor, as borrower, the Lenders from time to time party thereto, and the Agent;

WHEREAS, pursuant to the Loan Agreement, a lien on and security interest in (the "Security Interest") certain collateral, including the Intellectual Property Collateral (as hereinafter defined), was granted by Grantor to the Agent for the benefit of the Secured Parties (as defined in the Loan Agreement); and for the purpose of recording such Security Interest with respect to the Intellectual Property Collateral with the United States Patent and Trademark Office, the Grantor entered into that certain Intellectual Property Security Agreement dated as of November 30, 2015, (the "IP Security Agreement"), in favor of the Agent for the benefit of the Secured Parties;

WHEREAS, the IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on February 1, 2016 at Reel 5720, Frame 0210 and in the Patent Division of the United States Patent and Trademark Office on February 1, 2016 at Reel 037630, Frame 0127; and

WHEREAS, the requirements for release of the security interest granted in the Intellectual Property Collateral have been met, and the Agent now desires to terminate and release, on behalf of itself and the Secured Parties, the entirety of its Security Interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby agrees as follows:

1. Definitions. The term "Intellectual Property Collateral," as used herein, means all of the Grantor's right, title, and interest in, to, and under trademarks and registrations and applications for trademarks, including, without limitation, those listed on Schedule I annexed hereto (together with the goodwill of the business symbolized thereby), patents and patent applications, including, without limitation, those listed on Schedule II annexed hereto, copyrights, intellectual property licenses, and all products and proceeds thereof. Capitalized terms not defined herein have the meanings set forth in the Loan Agreement and IP Security Agreement, as applicable.

2. Release of Security Interest. Agent, on behalf of itself and on behalf of all Secured Parties as their agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels, releases, relinquishes, and discharges, in its entirety, for the benefit of Grantor and its successors, and the successors-in-interest and assigns to the Intellectual Property Collateral, all liens on and security interests of Agent or any Secured Parties in each case arising under the Loan Documents in and to the Intellectual Property Collateral, and any and all right, title and interest of the Agent and the Secured Parties in, to, and under the Intellectual Property Collateral shall hereby terminate, cease and become void.

3. Recordation. Grantor authorizes and requests that the Commissioner for Trademarks and Commissioner for Patents at the U.S. Patent and Trademark Office, the Canadian Intellectual Property Office, and any other appropriate agency record this Release.

4. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release.


5. Further Assurances. From time to time after the date hereof, upon Grantor's reasonable request, or upon the reasonable request of Grantor's successors, assigns or other legal representatives, Agent agrees to provide Grantor or its successors, and the successors-in-interest and assigns or other legal representatives with any information and additional authorization and documentation necessary to more fully and effectively effect the release of the liens and security interests of Agent and the Secured Parties in the Intellectual Property Collateral (without recourse, representation or warranty and at Grantor's sole cost and expense).

6. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
