ASSIGNMENT OF TRADEMARK

Assignor further agrees that, without further consideration, it will cause to be performed such other lawful acts, and to be executed such further assignments and other lawful documents, as Assignees may, from time to time, reasonably request to effect fully this Assignment and to permit Assignees to be duly recorded as the registered owner of the Trademark in the United States. Assignees shall be responsible for all fees for recordation of this Assignment and Assignor agrees to cooperate fully with Assignees to accomplish such recordation.





