The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Agent on behalf of the Secured Parties with respect to the Collateral are more fully set forth in the Loan Agreement, the IP Security Agreement and the Other Documents, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

All capitalized terms used herein without definition have the same meanings given to such terms in the Loan Agreement.
