## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This Release of Security Interests in Trademarks ("Release") is made as of the 30th day of April, 2018 (the "Release Date"), by GARRISON LOAN AGENCY SERVICES LLC, a Delaware limited liability company ("Secured Party") in favor of KRANOS ACQUISITION CORPORATION, a Delaware corporation ("Parent"), KRANOS CORPORATION, a Delaware corporation ("Kranos"), KRANOS IP CORPORATION, a Delaware corporation ("Kranos IP"), KRANOS IP II CORPORATION, a Delaware corporation ("Kranos IP2"), KRANOS RE CORPORATION, a Delaware corporation ("Kranos RE") and Kranos IP III Corporation, a Delaware corporation ("Kranos IP3") and together with Parent, Kranos, Kranos IP, Kranos IP2, and Kranos RE the "Grantors").

WHEREAS, a Trademark Security Agreement between the Secured Party and Grantors was recorded on June 15, 2012 by the Trademark Assignment Division of the U.S. Patent and Trademark Office, at Reel 4802, Frame 0618, as supplemented by that certain Trademark Security Agreement Supplement, recorded on April 9, 2014 at Reel 5257, Frame 0328, and as supplemented by that certain Trademark Security Agreement, recorded on December 18, 2014, at Reel 5421, Frame 0642 (as it may be from time to time amended, restated, amended and restated, modified or supplemented, the "Security Agreement").

WHEREAS, Secured Party has agreed to terminate, release and discharge its security interest in all the Trademarks listed on Schedule A (collectively, the "Trademarks").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantors and Secured Party hereby agree as follows:

All of Secured Party's security interests, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created against the Trademarks pursuant to the Security Agreement (collectively, the "Security Interests") are hereby automatically terminated, released and discharged, and the Secured Party shall sign any additional termination documents reasonably requested by Grantors at Grantors' cost and expense, including filings with the U.S. Patent and Trademark Office against the Trademarks, as shall be necessary to effect the termination, release and discharge of all of the Security Interests, each at Grantors' cost and expense.

If and to the extent that Secured Party has acquired any right, title or interest in or to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to Grantors, along with any goodwill in the Trademarks that the Secured Party may have acquired.

This Release shall be governed by the laws of the State of New York. This Release shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. This Release may be executed in any number of separate counterparts, each of which shall, collectively and separately, constitute one and the same instrument, and any signature page delivered by electronic transmission shall have same effect as the delivery of an original thereof. EACH PARTY TO THIS RELEASE HEREBY EXPRESSLY WAIVES, TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, ANY RIGHT TO TRIAL BY JURY OF

ANY CLAIM, DEMAND, ACTION OR CAUSE OF ACTION ARISING UNDER THIS RELEASE OR IN ANY WAY CONNECTED WITH OR RELATED OR INCIDENTAL TO THE DEALINGS OF THE PARTIES HERETO OR ANY OF THEM WITH RESPECT HERETO, OR THE TRANSACTIONS RELATED HERETO, IN EACH CASE WHETHER NOW EXISTING OR HEREAFTER ARISING, AND WHETHER FOUNDED IN CONTRACT OR TORT OR OTHERWISE; AND EACH PARTY HEREBY AGREES AND CONSENTS THAT ANY SUCH CLAIM, DEMAND, ACTION OR CAUSE OF ACTION SHALL BE DECIDED BY COURT TRIAL WITHOUT A JURY, AND THAT ANY PARTY TO THIS RELEASE MAY FILE AN ORIGINAL COUNTERPART OR A COPY OF THIS SECTION WITH ANY COURT AS WRITTEN EVIDENCE OF THE CONSENT OF THE SIGNATORIES HERETO TO THE WAIVER OF THEIR RIGHT TO TRIAL BY JURY.
