TRADEMARK ASSIGNMENT

This assignment is between Fantasia Distribution, Inc. ("Fantasia"), a California corporation located at 2400 E Katella Ave, Ste 800, Anaheim CA 92806, and Global Enterprise Manufacturing, Inc. ("GEM"), a California corporation located at 1560 S. Harris Ct., Anaheim, CA 92806.

Whereas, on July 1, 2015, as part of a rescission of the merger of Fantasia and Jarex, Inc., dba Hydro Herbal ("Jarex"), GEM was formed, in order to resume the operations that had been undertaken by Jarex and to take back the assets of Jarex that had been transferred to Fantasia by Jarex.

Whereas, in filings with the United States Patent and Trademark Office ("USPTO"), Fantasia has remained on title to the "Hydro" mark that was transferred to Fantasia as part of the subsequently rescinded merger.

Whereas GEM has adopted, used, and is using in its business in connection with the sale and distribution of herbal hookah products and related products the HYDRO trademark, registered with the USPTO under Registration No. 4737497.

WHEREAS, the parties desire that all right, title and interest in and to the HYDRO trademark, including the record title to the mark, together with the goodwill of the business connected with the use of and symbolized by the trademark, be vested in GEM;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Fantasia sells, assigns, and transfers to GEM such right, title, and interest in, to and under the HYDRO trademark, together with any goodwill of the business connected with the use of and symbolized by the trademark that Fantasia may have remaining, together with any right Fantasia may have had to sue for any past infringement of the Trademarks.


