RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of August 10, 2018 (the "Effective Date"), is made by BANK OF AMERICA, N.A., in its capacity as collateral agent for the Secured Parties (the "Agent"), in favor of the grantor parties identified on the signature page hereto (the "Grantors").

WHEREAS, pursuant to that certain U.S. Second Lien Pledge and Security Agreement, dated as of November 5, 2014, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantors granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered (x) a Second Lien Trademark Security Agreement, dated as of November 5, 2014 (the "DTZ Trademark Security Agreement"), (y) a Second Lien Trademark Security Agreement, dated as of December 31, 2014 (the "Cassidy Trademark Security Agreement"), and (z) a Second Lien Trademark Security Agreement, dated as of September 1, 2015 (the "Cushman Trademark Security Agreement" and, together with the DTZ Trademark Security Agreement and the Cassidy Trademark Security Agreement, the "Trademark Security Agreements"), for recordal with the United States Patent and Trademark Office;

WHEREAS, (x) the DTZ Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 6, 2014 at Reel/Frame 5395/0541, (y) the Cassidy Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 5, 2015 at Reel/Frame 5433/0967 and (z) the Cushman Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 3, 2015 at Reel/Frame 5616/0184;

WHEREAS, pursuant to the Trademark Security Agreements, the Grantors granted to the Agent a security interest in all of their right, title and interest in, to and under the Trademark Collateral (including the Trademarks set forth on Schedule A attached hereto); and

WHEREAS, the Agent desires to terminate and release any and all security interests, collateral pledges, grants and any other liens it has in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby absolutely, unconditionally and irrevocably releases, discharges, extinguishes, terminates and cancels, in its entirety, for the benefit of the Grantors and their successors and assigns, all of its security interest in and to the Trademark Collateral (including the Trademarks set forth on Schedule A attached hereto), arising under the Security Agreement and the Trademark Security Agreements, and all right, title or interest in and to the Trademark Collateral under the Security Agreement and the Trademark Security Agreements shall hereby cease and become void.

3. Termination. The Agent, without representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreements.

4. Further Assurances; Recordation. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release. The Agent and the Grantors hereby authorize and request that the Commissioner for Trademarks at the United States Patent and Trademark Office or its delegate record this Release against the Trademark Collateral.


5. Governing Law. This Release shall be governed by, and construed in accordance with, the law of the State of New York.

6. Miscellaneous. As used in this Release, the word "including" is not intended to be exclusive, or to limit the generality of the preceding words, and means "including, without limitation." This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf or .tif file) transmission shall be as effective as delivery of a manually signed counterpart of this Release. This Release may not be supplemented, altered or modified in any manner except by a writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this Release shall not waive any of its rights under such terms or provisions. This Release shall be binding upon the Agent's representatives, successors, assigns and transferees and is made in favor of and for the benefit of the Grantors and their successors and assigns.


