TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made on July 9, 2018 ("Effective Date"), between Virtual Hold Technology, LLC, a Delaware limited liability company ("Assignor"), and Virtual Hold Technology Solutions, LLC, a Delaware limited liability company ("Assignee," together with Assignor, the "Parties").

WHEREAS, Assignor desires to transfer, convey and assign to Assignee all of its right, title and interest in and to the trademark registrations and applications set forth in Exhibit A attached hereto and all issuances, extensions and renewals thereof and all goodwill associated therewith (collectively, the "Trademarks").

NOW, THEREFORE, for the consideration described in the Contribution Agreement between the Parties dated as of July 9, 2018, the sufficiency of which is hereby acknowledged, the Parties hereby agree to the following:

1. **Assignment**. Assignor hereby irrevocably conveys, transfers and assigns to Assignee all of Assignor's rights, title and interest in and to the Trademarks, including, without limitation: (i) all rights in and to the Trademarks accruing under any applicable law of any jurisdiction, international treaties and conventions or otherwise throughout the world; (ii) all rights to royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to the Trademarks; and (iii) all claims and causes of action with respect to the Trademarks, including, without limitation, all rights to pursue damages, injunctive relief and other remedies for past and future infringement, dilution or violation of the Trademarks.
2. **Recordation**. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office (and the officials of corresponding entities or agencies in any jurisdiction worldwide) to record and register this Assignment upon request by Assignee.
3. **Miscellaneous**. This Assignment will be binding upon and inure to the benefit of Assignor and Assignee and their respective successors and assigns. No amendment or modification of this Assignment is binding on the Parties unless made in a writing executed by duly authorized representatives of the Parties. This Assignment will be construed pursuant to the laws of the State of Delaware without regard to its conflicts of laws principles. All disputes arising under this Assignment will be heard exclusively in a court of competent jurisdiction in the County of Wilmington in the State of Delaware. This Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together will be deemed to be one and the same agreement.
