TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is effective as of April 30, 2018, by and between Cabrillo Community College District Financing Corporation, a California corporation ("Assignor"), and Community Initiatives, a California nonprofit public benefit corporation ("Community Initiatives").

WHEREAS, Assignor is the owner of the trademark ACADEMY FOR COLLEGE EXCELLENCE (Registration No. 4,144,512), and all other rights appurtenant, including, but not limited to common law rights, title and interest, trade name rights and the right to recover for past infringement, in the United States of America and all other countries and jurisdictions of the world, in and to said trademark and the registration thereof, (hereinafter collectively referred to as the "Trademark").

WHEREAS, Assignor is transferring to Community Initiatives certain assets that Community Initiatives is acquiring from Assignor in connection with Community Initiatives becoming the fiscal sponsor of the project known as the Academy for College Excellence (the "Project"), to which the Trademark pertains, which Project is ongoing and existing.

WHEREAS, Community Initiatives desires to acquire all rights, title and interest in and to the Trademark.

WHEREAS, in light of the foregoing, the parties acknowledge that this Assignment is intended to effectuate an assignment to Community Initiatives of all rights in and to the Trademark and registration issuing therefrom, and all the goodwill of the Trademark associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby irrevocably assigns, conveys, delivers, grants, sells and transfers to Community Initiatives all right, title and interest throughout the world in and to (i) the Trademark and registrations issuing therefrom, together with the goodwill of the Trademark symbolized thereby, (ii) all damages, income, payments and royalties now or hereafter due or payable in respect to the Trademark; (iii) all causes of action, either in law or in equity, for past, present, or future infringement based on the Trademark or any portions thereof, together with the right to sue for and collect, counterclaim and recover for the same; and (iv) the registration and the right throughout the world to file applications and/or renewals and obtain trademark registrations in the Trademark in Community Initiatives's own name throughout the world, including, without limitation, all rights of priority. Assignor further waives or releases any rights of restraint or moral rights in and to the Trademark.




