TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “**Termination and Release**”) is granted as of August 8, 2018 by **OFS AGENCY SERVICES, LLC**, a Delaware limited liability company, as administrative agent (the “**Agent**”), in favor of **STANCOR, L.P.**, a Delaware limited partnership (“**Grantor**”).

WHEREAS, Grantor executed and delivered a Trademark Security Agreement dated as of August 19, 2014, (as amended, modified or supplemented prior to the date hereof, the “**Trademark Agreement**”; capitalized terms used but not defined herein shall have the meaning ascribed to them in the Trademark Agreement), in connection with that certain Note Purchase Agreement, dated as of August 19, 2014, (as amended, restated, supplemented and/or modified from time to time), granting the Agent a security interest in and lien on certain trademarks described therein (the “**Trademark Collateral**”);

WHEREAS, the Trademark Agreement was recorded with the United States Patent and Trademark Office (“**USPTO**”) on September 24, 2014, at Reel 005368, Frame 0324; and

WHEREAS, the Grantor has requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Trademark Agreement and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including, without limitation, the Trademark Collateral identified in Schedule I hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. agrees that it shall, and at the Grantor’s, or its respective successor’s or assign’s, reasonable request, execute, acknowledge and deliver to the Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.


