**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of August 14, 2018, by, **JEFFERIES FINANCE LLC**, a Delaware limited liability company (the “Collateral Agent”) in favor of **SALLYPORT GLOBAL HOLDINGS INC.**, a Delaware corporation, with an address at 11921 Freedom Drive, Suite 1000, Reston, Virginia 20190 (the “Grantor”).

WHEREAS, the Grantor entered into a certain trademark security agreement dated November 21, 2017 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on November 21, 2017 at the United States Patent and Trademark Office at Reel 6210, Frame 0615.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to its Trademark Collateral, including the Trademark listed in Schedule A.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in such Trademark Collateral as herein provided.
