**PARTIAL TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Partial Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of August 14 2018, by **CITIZENS BANK OF PENNSYLVANIA**, as Administrative Agent (the “Administrative Agent”) in favor of **SALLYPORT GLOBAL HOLDINGS INC.**, a Delaware corporation, with an address at 11921 Freedom Drive, Suite 1000, Reston, Virginia 20190 (the “Released Grantor”).

W I T N E S S E T H:

WHEREAS, the Released Grantor (and the other “Grantors” party thereto and as defined therein) entered into a certain trademark security agreement dated November 21, 2017 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on November 21, 2017 at the United States Patent and Trademark Office at Reel 6210, Frame 0604.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Released Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to its Trademark Collateral, including the Trademark listed in **Schedule A**.


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in the Trademark listed in **Schedule A** as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the Secured Parties referred to in the Trademark Security Agreement, hereby releases, terminates and discharges any and all of its interest in the Released Grantor’s Trademark Collateral, including the Trademark listed in **Schedule A** hereto, and assigns, transfers and conveys to Released Grantor, without recourse to or warranty by the Administrative Agent, any interest in the Released Grantor’s Trademark Collateral, including the Security Interest. Except as expressly set forth herein, nothing contained herein shall otherwise terminate, release, waive, limit, impair or otherwise affect the Trademark Security Agreement and the continuing security interest held by the Administrative Agent in the Trademark Collateral, as previously granted under the Trademark Security Agreement by the Grantors (other than the Released Grantor) to the Administrative Agent.
