**RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS** (this "Release") is made as of June 15, 2018 ("Effective Date") in favor of GARDEN CITY GROUP, LLC, a Delaware limited liability company ("Pledgor"), by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent (the "Administrative Agent").

**WHEREAS**, Pledgor and the Administrative Agent entered into that certain Amended and Restated Pledge and Security Agreement by, among others, Grantor in favor of the Administrative Agent, dated as of October 11, 2017 (the "Security Agreement");

**WHEREAS**, pursuant to the Security Agreement, Grantor granted to the Administrative Agent a security interest in all of its right, title and interest in, to and under certain intellectual property and entered into that certain Grant of Security Interest in Patents and Trademarks (the "Intellectual Property Security Agreement") for the purpose of recording such security interest with respect to the patents, trademarks and applications therefor of Grantor, including those items set forth on Schedule A hereto (collectively, the "Intellectual Property Collateral"), with the United States Patent and Trademark Office;

**WHEREAS**, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on October 16, 2017, at Reel 006182, Frame 0984; and

**WHEREAS**, the Administrative Agent has agreed to release its liens on the Intellectual Property Collateral.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates the Intellectual Property Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the Intellectual Property Collateral to Grantor.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
