RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS** (this "Release"), dated as of August 13, 2018 (the "Effective Date"), is made by JPMorgan Chase Bank, N.A., in its capacity as administrative agent pursuant to the Credit Agreement (as defined below) (in such capacity, the "Agent") for the Secured Parties, in favor of Conduent (as defined below) and Conduent HR Consulting, LLC (f/k/a Buck Consultants, LLC) (together with Conduent, the "Grantors").

WHEREAS, Conduent Business Services, LLC (f/k/a Xerox Business Services, LLC) a Delaware limited liability company ("Conduent"), the Agent and the other parties thereto entered into that certain Credit Agreement, dated as of December 7, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, the Grantors, the Agent and the other parties thereto entered into that certain Security Agreement, dated as of December 7, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors pledged, collaterally assigned, mortgaged, transferred and granted to the Agent, on behalf of and for the benefit of the Secured Parties, a continuing security interest in all of the Grantors' right, title and interest in, to or under the trademarks set forth in Schedule I hereto ("Trademark Collateral");

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered (i) a Trademark Security Agreement, dated as of December 7, 2016 and (ii) a Trademark Security Agreement, dated as of May 4, 2017 (collectively, the "Trademark Security Agreements"), for recordation with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on (i) December 8, 2016 at Reel/Frame 5942/0188 and (ii) May 8, 2018 at Reel/Frame 6052/0790, respectively; and

WHEREAS, pursuant to that certain Confirmation of Release of Liens and Termination of Guarantee, dated as of August 13, 2018, entered into by the Agent, as Administrative Agent and as Collateral Agent and the Grantors, the Agent has agreed to release the security interest granted to the Agent in and to the Trademark Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release and Termination. The Agent, without representation or warranty of any kind, on behalf of the Secured Parties, hereby terminates, cancels, releases and forever discharges the security interest in the Trademark Collateral, and retransfers and reassigns to the Grantors any right, title or interest the Agent may have in, to or under the Trademark Collateral. For clarity, the Agent is only terminating, releasing and discharging its security interest in the trademarks set forth in Schedule I hereto, and all other security interests granted to the Agent with respect to all other collateral pursuant to the


Security Agreement and the Trademark Security Agreements shall continue in full force and effect, and the Agent's security interest, liens, rights, titles and interests in such other collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Release.

3. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
