RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Release"), effective as of June 29, 2018, given by **U.S. BANK NATIONAL ASSOCIATION**, as Collateral Agent ("Agent"), to **MICRON TECHNOLOGY, INC.**, a Delaware corporation ("Grantor"), as follows:

W I T N E S S E T H

WHEREAS, the Grantor and MICRON SEMICONDUCTOR PRODUCTS, INC., an Idaho corporation, have entered into that certain Indenture, dated as of April 26, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Indenture"), with Collateral Agent and U.S. Bank National Association, as trustee;

WHEREAS, in connection with the Indenture, the Grantor executed that certain Security Agreement, dated as of April 26, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), and granted to the Agent a security interest in the United States trademark registration and applications set forth on Schedule A attached hereto (the "Trademarks") to secure the Obligations (as defined in the Security Agreement);

WHEREAS, in furtherance of the Security Agreement, the Grantor executed a Supplement No. 6 to Trademark Security Agreement dated October 23, 2017 (the "Trademark Security Agreement"), which was recorded by the U.S. Patent and Trademark Office on November 1, 2017, at Reel / Frame no. 6194 / 0528; and


WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to terminate the encumbrance created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates, releases, cancels, relinquishes and discharges the security interest in the Trademarks created by the Trademark Security Agreement and the Security Agreement and reassigns all right, title and interest it has in the Trademarks to the Grantor.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE GRANTOR'S AND THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
