TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (“Termination and Release”), dated as of August 16, 2018, from WELLS FARGO BANK, NATIONAL ASSOCIATION, successor to Stellus Capital Investment Corporation, as the administrative agent (the “Agent”) to RELIABLE CONSTRUCTION HEATING & COOLING, LLC (the “Grantor”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Amended and Restated Credit Agreement, the Amended and Restated Guaranty and Security Agreement, the Trademark Security Agreement or the Assignment of Intellectual Property Security Agreements, as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Guaranty and Security Agreement, dated as of July 26, 2017, as amended and restated as of September 28, 2017, the Grantor executed a Trademark Security Agreement, dated as of July 26, 2017, which was recorded in the United States Patent and Trademark Office on July 26, 2017 at Reel 6114, Frame 0880, pursuant to which the Grantor granted a security interest to Stellus Capital Investment Corporation, as administrative agent, for the benefit of the Secured Parties, in the Trademark Collateral, including certain trademarks and/or trademark applications listed on Schedule A hereto and made a part hereof, which was subsequently assigned to Agent under that certain Assignment of Intellectual Property Security Agreements, dated as of September 28, 2017, which was recorded in the United States Patent and Trademark Office on September 28, 2017 at Reel 6164, Frame 0042.

WHEREAS, the Agent now desires to terminate the Trademark Security Agreement and terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


1. Agent hereby terminates the Trademark Security Agreement and terminates and releases its security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral, including those trademarks set forth on Schedule A.

2. Agent hereby assigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, any and all of Agent’s right, title, and interest in and to the Trademark Collateral, together with, among other things, the goodwill of the business symbolized by the trademarks and the applications and registrations thereof.
