TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of July 10, 2018, by NXT CAPITAL, LLC, as Administrative Agent and Collateral Agent (“Administrative Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Interkontinental Investments Manufacturing, LLC, a Florida limited liability company (“Grantor”), and Administrative Agent are parties to a Trademark Security Agreement dated as of August 31, 2015 (the “Security Agreement”), pursuant to which Grantor granted a security interest to Administrative Agent for the benefit of the Secured Parties, in the Trademark Collateral as security for certain obligations owing by Grantor to the Secured Parties including certain trademarks (the “Trademarks”) set forth on Schedule A hereto; and

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on September 1, 2015 at Reel 5614, Frame 0234; and

WHEREAS, Grantor has requested that Administrative Agent release its security interest in the Trademarks and Trademark Collateral and reassign the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral, including the Trademarks set forth on Schedule A.

2. Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse, warranty or undertaking by Administrative Agent, all of Administrative Agent’s right, title and interest in and to the Trademark Collateral and the Trademarks.


