TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release"), dated as of August 17, 2018, is made by SUNTRUST BANK, in its capacity as administrative agent ("Agent") for itself, its successors and permitted assigns, and the Secured Parties (as defined in the Security Agreement referred to below) in favor of Advisor Group, Inc., a Maryland corporation (the "Grantor").

WHEREAS, pursuant to (i) the Guaranty and Security Agreement, dated as of June 29, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Grantor, Advisor Group Holdings, Inc., a Delaware corporation, Financial Service Corporation, a Georgia corporation, FSC Agency, Inc., a Georgia corporation, and the Agent, and (ii) the Trademark Security Agreement, dated as of June 29, 2017 (the "Trademark Security Agreement"), by and among the Grantor and Agent, the Grantor has granted a continuing security interest in and continuing lien upon the Trademark Collateral, including the registered trademarks shown on Schedule A (the "Trademarks");

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on June 29, 2017 at Reel 6094 Frame 0745; and

WHEREAS, Agent (acting at the direction of the Secured Parties) now desires to terminate and release the entirety of its security interest in the Trademarks.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent (for itself and as Agent for the Secured Parties) and the Grantors agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement as the context may require.

SECTION 2. Termination and Release. The Agent (acting at the direction of the Secured Parties), for itself and as Agent for the Secured Parties, hereby:

(a) terminates, releases, and discharges its continuing security interest in and continuing lien upon the Trademark Collateral. Any and all right, title, or interest of Agent in the Trademark Collateral and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Trademarks and any and all causes of action which may exist by reason of infringement of the Trademarks, shall hereby cease and become void;

(b) authorizes the recordation of this Release with the USPTO;

(c) releases without any recourse to the Agent (whether as Agent or in its personal capacity) and without any statement, representation, warranty, promise or undertaking whatsoever by the undersigned (whether as Agent or in its personal capacity), whether express or implied; and


(d) agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantor's counsel and the cost and expense of such documents and actions shall be borne solely by the Grantor.

This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.


