**RELEASE OF SECURITY INTEREST**

This Release of Security Interest is made as of August 17, 2018 (this "Release"), by EAST WEST BANK ("Lender"), in favor of DROBO INC., a Delaware corporation ("Company"), with its principal place of business located at 1289 Anvilwood Avenue, Sunnyvale, CA 94089.

Recitals

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of May 15, 2015 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Security Agreement"), by and between the Company and Lender, the Company granted to the Lender a security interest in all of its right, title and interest in, its Intellectual Property Collateral (as defined in the Security Agreement and including, without limitation, the patents and trademarks listed on Schedules A and B hereto), and all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof (collectively, the "IP Collateral").

WHEREAS, the Security Agreement was recorded against the patents listed on Schedule A with the United States Patent and Trademark Office (the "USPTO") on May 18, 2015, at Reel 035663, Frame 0328.

WHEREAS, the Security Agreement was recorded against the trademarks listed on Schedule B with the USPTO on May 18, 2015, at Reel 5519, Frame 0046.

WHEREAS, Company has repaid all of its obligations to Lender that were secured by the Security Agreement, and the Lender has agreed to release its security interest in the IP Collateral.


Agreement

NOW THEREFORE, Lender hereby agrees that the Security Agreement is terminated and irrevocably terminates, releases and discharges all liens, security interests and any other rights that are or may have been granted to the Lender in and to the IP Collateral.

The Lender hereby authorizes the Company (or its assignee) to record this Release with the USPTO and requests that the Commissioner of Patents and Trademarks record this Release.
