DECLARATION

I am authorized to execute this document on behalf of the owner, HARRY'S, INC.

1. Effective as of August 29, 1991, M-F-G CORPORATION, an ILLINOIS corporation and at that time the owner of the trademark FLAMINGO (Stylized), U.S. Reg. No. 500152 (hereinafter, the "Trademark"), assigned the Trademark and the above-named registration therefor, together with the goodwill of the business symbolized by the Trademark, to Morris-Flamingo, Inc., a corporation of Georgia. This assignment was recorded in the USPTO at Reel/Frame 0813/0215. In the assignment document, the assignee's entity type and citizenship were described as "corporation of Illinois." This was a clerical error as Morris-Flamingo, Inc. was a corporation of Georgia. The owner is now recording a corrective assignment in the USPTO's Assignments Branch.

2. On March 5, 1992, **Morris-Flamingo, Inc.**, a Georgia corporation, assigned a group of trademarks to **M-F Beauty Products, L.P.**, a Georgia limited partnership. However, due to a clerical error, the Trademark was omitted from the schedule of registrations to be assigned. The owner of the Trademark will next record a corrective assignment in the USPTO's Assignments Branch.

3. On March 10, 1992, **M-F Beauty Products, L.P.**, a Georgia limited partnership, changed its name to **Morris-Flamingo, L.P.**, a Georgia limited partnership. That change of name will be recorded to complete the record.

4. The recorded assignment history after March 10, 1992 is correct. **Morris-Flamingo, L.P.**, a Georgia limited partnership, assigned the Trademark to **MORRIS FLAMINGO STEPHAN, INC.**, a Florida corporation (recorded in the USPTO at Reel/Frame 1714/0960). Further, **MORRIS FLAMINGO STEPHAN, INC.**, a Florida corporation, assigned the Trademark to the current owner, **HARRY'S, INC.**, a Delaware corporation (recorded in the USPTO, at Reel/Frame 6248/0979).

Therefore, **HARRY'S, INC.**, a Delaware corporation is the current owner of the Trademark and the above-named registration therefor.
