This Assignment, to the extent signed and delivered by means of a facsimile machine or electronic transmission in portable document format ("PDF") or any electronic signature complying with the U.S. E-SIGN Act of 2000, shall be treated in all manner and respects as an original agreement or instrument and shall be considered to have the same binding legal effect as if it were the original signed version thereof delivered in person.
