**TRADEMARK RELEASE**

August 20, 2018

**WHEREAS**, HOME BRANDS, LLC, a Delaware limited liability company (the “**Grantor**”), among others, granted to WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as agent for the Lender Group and Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, the “**Agent**”), a Security Interest in certain Trademark Collateral as set forth in that certain Trademark Security Agreement, dated October 18, 2016 by the Grantor in favor of the Agent (the “**Trademark Grant**”; capitalized terms used but not defined herein having the meaning assigned to such terms in the Trademark Grant), which was recorded in the United States Patent and Trademark Office (the “**USPTO**”) on October 19, 2016 at Reel 5904, Frame 0684; and

**WHEREAS**, the Grantor has requested that the Agent release and reassign to the Grantor its interest in the trademarks identified in **Schedule A** hereto and made a part hereof;

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby:

1. releases, fully discharges and reassigns to Grantor any and all liens, security interests, right, right of control, title and interest, including its Security Interest, of the Agent pursuant to the Trademark Grant in the trademarks identified in **Schedule A**, all proceeds and products of the trademarks identified in **Schedule A**, all goodwill associated with any of the trademarks identified in **Schedule A**, and all causes of action for infringement of the trademarks identified in **Schedule A**, without recourse or representation or warranty, express or implied of any kind;
2. to the extent that Agent has any remaining right or interest in Grantor’s trademarks identified in **Schedule A**, the Agent hereby assigns and agrees to assign such remaining right or interest to Grantor; and
3. authorizes and requests that the USPTO note and record the existence of the release hereby given.

Notwithstanding the foregoing, the Trademark Grant remains in full force and effect with respect to any and all Trademark Collateral other than the trademarks identified on **Schedule A**.
