RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

WHEREAS, Zipscene, LLC, an Ohio limited liability company (the "**Grantor**"), granted to Pacific Western Bank, as successor in interest by merger to Square 1 Bank, (collectively, "**Bank**") a security interest (the "**Security Interest**") in all of Grantor's right, title and interest in, to and under Grantor's intellectual property (the "**Intellectual Property**"), including without limitation (i) the trademarks and the United States trademark registrations listed on the attached **Exhibit A** (the "**Trademarks**"); and (ii) the United States patents and patent applications listed on the attached **Exhibit B** and the inventions disclosed or claimed therein (the "**Patents**"); and including without limitation all proceeds thereof, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuation-in-part thereof (the "**Other Rights**"), under an Intellectual Property Security Agreement entered into as of October 10, 2014 (the "**IP Security Agreement**");

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on October 20, 2014, at Reel 5384/Frame 0294, and at Reel 033983/Frame 0930, and on January 4, 2016 at Reel 5701/Frame 0133; and

WHEREAS, Grantor has no outstanding obligations to Bank under the terms of the IP Security Agreement, Bank agrees to release the Security Interest.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Bank hereby agrees as follows:

1. Bank hereby terminates the IP Security Agreement, releases the Security Interest, and assigns to Grantor, without warranty or recourse, all right, title and interest of Bank in, to and under the Intellectual Property, including without limitation the Patents and Trademarks, and the Other Rights; and
2. Bank authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the releases and assignments hereby given.


Successors and Assigns. This Release of Security Interest in Trademarks and Patents shall be binding upon successors and assigns of the Bank.
