AGREEMENT REGARDING TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS AGREEMENT REGARDING TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination"), is dated as of August 17, 2018, but is effective for all purposes as of April 20, 2018 (the "Effective Date"), and made by **MONROE CAPITAL MANAGEMENT ADVISORS, LLC**, in its capacity (in such capacity, "Grantee") as administrative agent for and on behalf of the Lenders as defined in that certain Credit Agreement dated May 2, 2017 by and among Grantee and Grantors, in favor of Curion Solutions, LLC (fka Tragon, LLC), a Delaware limited liability, RedJade Software Solutions, LLC, a Delaware limited liability company, Curion Parent, LLC (fka Q-Tragon Parent, LLC), a Delaware limited liability company, Curion Holdings, LLC (fka Q-Tragon Holdings, LLC), a Delaware limited liability company, and Curion, LLC (fka Q Research Solutions Holdings, LLC), a Delaware limited liability company (jointly and severally, "Grantors" and each individually "Grantor").

WHEREAS, pursuant to that certain Guaranty and Collateral Agreement dated as of May 2, 2017, and that certain Joinder to Guaranty and Collateral Agreement dated May 2, 2017, by and among Grantors and Grantee (collectively, as amended to date, the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral (the "Collateral").

WHEREAS, the Collateral includes those Trademarks listed on Exhibit A hereto (the "Released Trademarks");

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on May 3, 2017, at Reel 6048 and Frame 0237; and

WHEREAS, Grantee desires to terminate and release its security interest in and with respect to the Released Trademarks effective as of the Effective Date.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. Capitalized terms used herein are used as defined in the Security Agreement.
2. Release of Security Interest. Effective as of the Effective Date, Grantee hereby terminates, releases and discharges its security interest in and with respect to the Released Trademarks, together with any renewals or divisional thereof and all goodwill associated therewith, and all products and Proceeds of the foregoing, including without limitation, any royalties or any claim by Grantors against third parties for past, present or future infringement of any Released Trademark, and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in all of the foregoing.


