NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

– TRADEMARKS –

August 22, 2018

WHEREAS, Black Knight Sports and Entertainment LLC, a Delaware limited liability company (the “Grantor”), is the owner of the trademarks set forth in Schedule A opposite its name, as well as the goodwill underlying such trademarks (collectively, the “Trademarks”); and

WHEREAS, CITIBANK, N.A., as administrative agent (together with its successors and permitted assigns in such capacity, the “Administrative Agent”), with offices at 153 E. 53rd Street, 18<sup>th</sup> Floor, New York, NY 10022, entered into an Amended and Restated Security Agreement dated as of August 22, 2018 and a Trademark Security Agreement dated as of March 1, 2017, with Grantor and others, as amended from time to time, by which Grantor granted to the Administrative Agent a security interest in certain property, including the Trademarks, in consideration for a loan.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby confirms the granting to the Administrative Agent of a security interest in the Trademarks, subject to the terms set forth in the above-referenced agreements.

It is acknowledged, understood and agreed that, notwithstanding anything in this document or any other Operative Document to the contrary, (a) the exercise by any Lender of remedies under any Operative Document will be made in accordance with the terms and provisions of the NHL Letter Agreement, the terms, conditions and provisions of which each of the parties to any Operative Document has accepted as reasonable and appropriate, and (b) in the event of any conflict or inconsistency between the terms of the NHL Letter Agreement and the terms of any Operative Document (including without limitation this document/agreement), the terms of the NHL Letter Agreement will control. All capitalized terms used in this section and not defined in this section are defined in that certain letter agreement, dated as of August 22, 2018 by and among the NHL, Citibank, N.A., as collateral agent, sole lead arranger and lender, Black Knight Sports and Entertainment LLC, Black Knight Sports and Entertainment Holdco LLC and the other parties thereto, as the same may be amended, restated, amended and restated, replaced, supplemented or otherwise modified from time to time (the “NHL Letter Agreement”). For the avoidance of doubt, each Club Party acknowledges and agrees that nothing herein or in any other Operative Document shall give any Club Party an independent right to invoke or enforce any right or remedy set forth in the NHL Letter Agreement.


