**ASSIGNMENT OF INTELLECTUAL PROPERTY  
SECURITY AGREEMENT**

This ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Assignment"), dated as of July 13, 2018, is by BMO HARRIS BANK N.A. (individually, "BMO Harris"), acting in its capacity as the current and resigning administrative agent (in such capacity, the "Retiring Agent") and BANK OF MONTREAL (individually, "Bank of Montreal"), acting in its capacity as the successor administrative agent (in such capacity, the "Successor Agent").

**RECITALS:**

WHEREAS, SEKO WORLDWIDE, LLC, a Delaware limited liability company (the "Grantor"), and Retiring Agent are parties to that certain intellectual property security agreement identified on Exhibit A attached hereto (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, the "Agreement") covering certain intellectual property set forth on Exhibit B attached hereto; and

WHEREAS, pursuant to that certain Agreement Regarding Agency Resignation, Appointment and Acceptance by and among BMO Harris, as the Retiring Agent, Retiring Swing Line Lender and Retiring Letter of Credit Issuer, and Bank of Montreal, as Successor Agent, Successor Swing Line Lender and Successor Letter of Credit Issuer, and acknowledged by the Borrowers party thereto, Retiring Agent has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreement, in each instance, in its capacity as administrative agent.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Retiring Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreement.

This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.


